"We will do our best to keep our members informed of any new information as it becomes available. We are doing what is best for the safety and well-being of our employees and members by closing our lobby, suspending disconnects and late fees, and postponing the annual meeting."

LOCALLY OWNED, LOCALLY FOCUSED Hunt Family Farm supports community

The Hunt Family Farm in Amboy, co-owned by father Jack and son Nathan Hunt, is a sixth generation farm founded in 1848. The farm consists of 760 acres where the men grow corn, beans and wheat as well as raise hogs. It is just one in a chain of small businesses in rural Miami County supporting each other.

The farm's hog operation takes up most of their time. What sets them apart from more commercially-run operations is that they own their hogs. The Hunts have approximately 50 sows they breed and then sell the offspring.

The farm breeds them wider than what is customarily done, so that the hogs have a lot of meat on their sides. Hunt Family Farm's hogs grow a little slower, as they have

access to five acres of pasture, and are usually ready to be sold in about six to eight months.

Another aspect of the business that separates them from others is that the Hunts grow all their own corn (the main ingredient in the hogs' feed) on the farm. In addition to the corn, the Hunts also mix sunflower meal (a biproduct from sunflowers) into the hogs' feed. They purchase the sunflower meal from Healthy Hoosier Oil located just down the road in Converse.

Last year, the farm sold approximately 400 hogs. About half were sold to Jefferson BBQ in Converse, demonstrating yet another way they are helping and supplying other local businesses. The other half was sold to local families for freezer meat and to Eskanazi Hos-

pital in Indianapolis. Most of the meat sent to the hospital is used for its Meals on Wheels program. Jefferson BBQ also purchases sunflower oil from Healthy Hoosier Oil.

If you would like to taste meat from Hunt Family Farm, you can buy cuts at yet another local business. Rachel's Taste of Indiana, located across the street from Jefferson Street BBQ in Converse, sells the farm's pork offerings.

In addition to farming, Nathan supports his local community as a firefighter in Peru. Jack also keeps busy through running Converse Hardware and Supply.

Spring into farm electrical safety

Know what to do if electrical contact occurs.

IF YOU'RE INSIDE THE MACHINERY WHEN COMING IN CONTACT WITH A DOWNED POWER LINE:

If you can, drive safely away from the downed power line and the source of electricity. Travel at least three tractor lengths, or about 40 feet, before stopping.

If you can't drive or you are injured, it's best to stay where you are until help arrives.

If you must get out of the machinery because of a lifethreatening reason, don't touch the machinery and the ground at the same time with any part of your body or clothing.
