#### **2020 ANNUAL MEETING REMARKS**



Miami-Cass REMC's CEO, I have the privilege of addressing you, our members, at our Member Appreciation

Day/Annual Meeting. Here are a few highlights from my address during our virtual meeting on Sept. 15.

It felt very strange addressing everyone sitting in a chair in our boardroom instead of standing at a podium with bright lights in my face. I was joined by six of your seven elected board members: Board President Jim Savage, Board Vice President Todd Smith, Board Secretary Cindy Scott, Mark Hahn, Tony Caldwell, and Scott Marschand. Also in attendance were Director of Member Services Kim Burton, REMC employees Mike Barron and Liz Vance, meeting secretary Shelly Glassburn and board attorney Jeremy Fetty.

As mentioned in the September Indiana Connection magazine, we had an uncontested board of directors election this year. As such, Tony Caldwell and Todd Smith were each re-elected to serve as a director in his district for at least three more years.

I'm not going to talk much about the craziness going on right now. I'm sure many of you out there, like me, are getting worn out by all of it. During all of this we were slowed down for a while, like the rest of world, but we did not shut down completely. Thankfully, as of today, we have not had any employee or director who has contracted COVID-19. However, some have had friends and family who have had it. It saddens me to say this, but I think we will be dealing with this pandemic for a while longer.

#### STATE OF THE REMC

It's strange that, in the midst of all of the craziness, we seem to have one of our busiest years since 2008. For the past 12 years, we had been growing close to 30 meters per year, However, this year we are already at the 50-meter mark. This can be attributed, in part, to the low interest rates we are seeing. On top of the growth, we have been busy with upgrades to the system, rebuilding lines and refurbishing a substation.

We remain strong financially and do not foresee any rate changes for 2021, making this our sixth year without a rate increase. In the last rate study conducted, it was projected our current rates would last six to seven years. At the end of 2021 we will evaluate to see if another study is needed for 2022. Be assured that we always work hard to keep our rates as low as possible.

#### ACQUISITION OF BROADWAY BROADBAND

In late January Miami-Cass REMC purchased Broadway Broadband. We made this acquisition for a couple reasons. First to give our underserved members a chance to receive fast, reliable internet. Second was to increase our communications between our electric grid and meters. We looked at several ways to accomplish this, and the purchase of an existing company made the most sense.

An already established company, with experienced employees

and infrastructure, gave us the opportunity to control the means by which we get these services to our members. Broadway Broadband had 1,100 customers when we purchased it. We are now up to 1,300 customers, most of which are served wirelessly.

Our priority is to install fiber to all areas where it is fiscally responsible. In the areas where it is not, we will provide a high-speed wireless option. We will be hooking up customers in stages as we build the fiber ring out. Initially, progress has been slow. This is new for us and we want to ensure the right approach is taken to the project. The COVID-19 virus has also slowed down our ability to get material. As we are getting our feet wet, our construction is getting faster and our employees are gaining more experience.

We will be contacting homes that are in the areas where we are working as we build the ring out. We are starting in the areas with the highest concentration of people, as this will allow for increased revenue to help fund the project. If you have any questions, call the office at 765-473-6668.

I want to thank all of the Miami-Cass REMC and Broadway Broadband employees for their dedication to our companies. I would also like to thank our board of directors for its guidance throughout the year. It is truly a team effort that makes these companies run smoothly and efficiently. # ANNUAL MEETING *Recap*

Miami-Cass REMC's 81st Member Appreciation Day and Annual Meeting was held virtually Sept. 15, 2020, at the Miami-Cass REMC headquarters. A total of 372 members submitted their voting cards to the REMC prior to the meeting, which represents nearly 7.58 percent of the total voting membership.

Kim Burton, Miami-Cass REMC director of member services, welcomed everyone; Pastor Cole Westwood gave the invocation; and the national anthem was played.

REMC Board President Jim Savage then called the meeting to order and thanked everyone who was able to join the first-ever virtual annual meeting. He stated that in much the same way that the REMC set out to help drastically improve the lives of those in rural Miami and Cass counties by bringing them electricity, the cooperative is now working to bring high-speed internet to those same rural areas by building a fiber optic network. Savage also stated that all Miami-Cass REMC and Broadway Broadband employees are dedicated to bringing the best, most-reliable electric and internet service to their members. Lastly, he mentioned that the board had recently accepted and approved the annual audit.

CEO Rob Schwartz then addressed the members (see highlights on page 5-6).
